Getting a phone line at the 2017 Mudgee Small Farm Field Days

Telephone lines are most commonly used at the Mudgee Small Farm Field Days for EPTPOS. Telstra is responsible for supplying the lines from the exchange to our site. Our site has underground telephone infrastructure, and whilst it covers a lot of the site it does not reach everywhere.

Telstra no longer will connect lines through to the site if it is not straight forward, if it requires extra work this will be completed by a local contractor.

Follow these steps;

1. Complete the attached form.
 2. Authorise our contractor to deal with Telstra on your behalf
 3. Fax it to Telstra on the number indicated.
 4. Fax another copy of the form to us at AREC.
- By faxing a copy to us we can check where your site will be relative to available phone infrastructure.
 - Our contractor, Mudgee Phone Company, who will be on site to make the connection can review your needs and advise of any issues about the supply of the phone service well in advance of the event.
 - By giving our contractor authority to act for you in the connection of the phone service, they can check on phone line availability and physical allocation. They can also ensure that the correct fees are charged by Telstra, especially when the service is in place from the previous year.

By following these steps, we can help exhibitors complete a successful phone connection.
